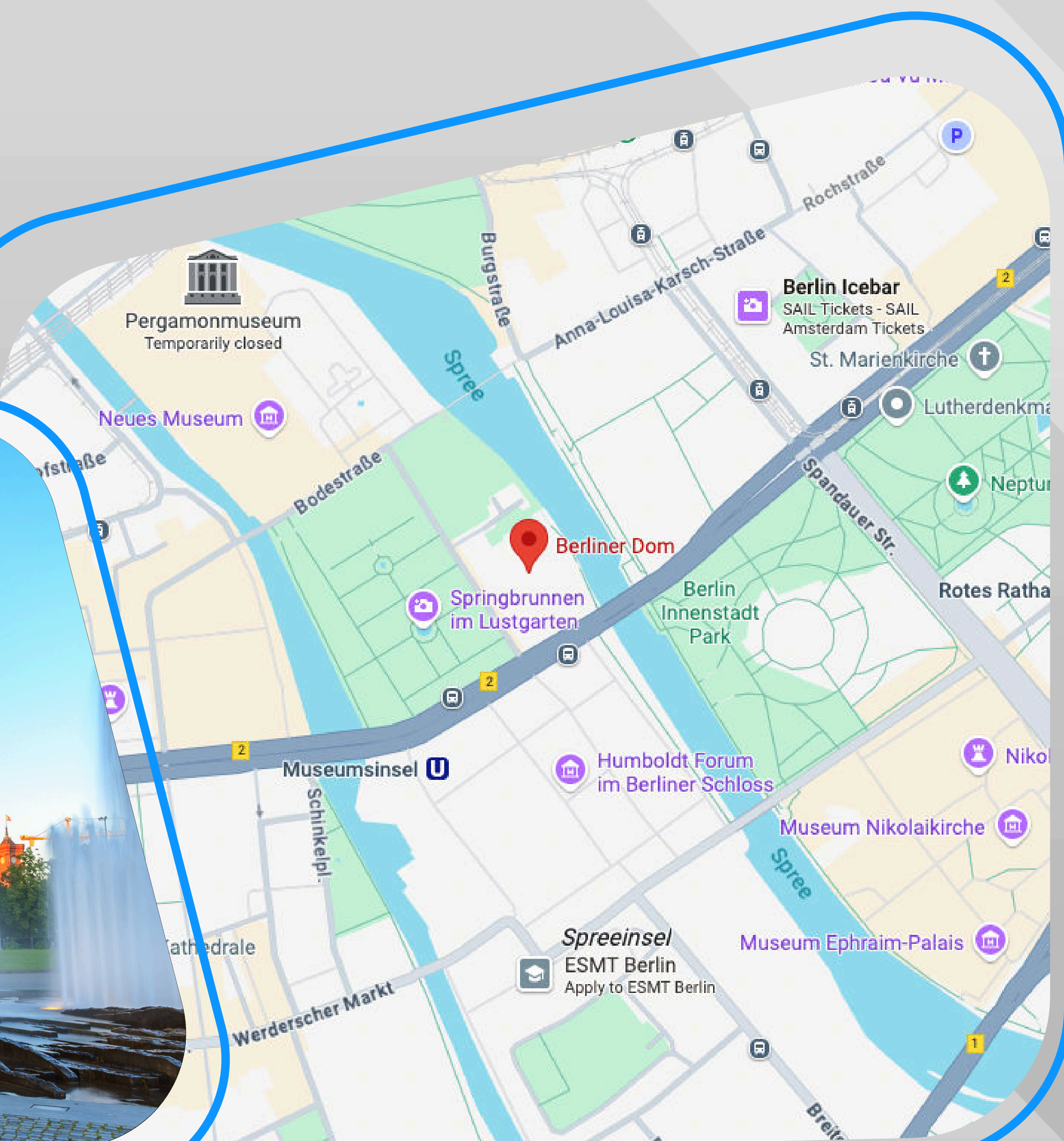
The Berlin Cathedral at its main steps/entrance.

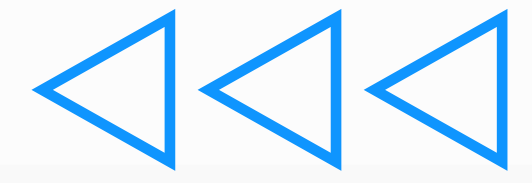

Overview of your Berlin tour:

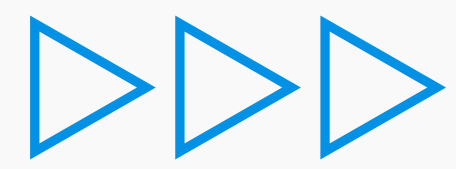
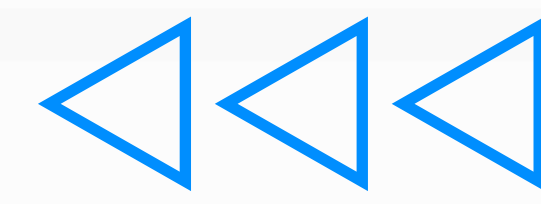
Berlin is a combination of grit and glamour, culture and techno, with tangible history and a vibrant present that has not forgotten its past. This panoramic tour is best for first-time visitors and will give you a well-rounded impression of what is most important. Discover the surprising origins of this green metropolis and get a feel of how the city grew through the centuries into the Prussian Empire to end up as the birthplace of the Avant Guard in the Golden '20s: inspiring, tolerant, progressive, and explosive. This "Babylon", with the imminent rise of the Nazi movement, came to a screeching halt in 1933. Hitler's megalomaniac plans to create "Germania", the capital of the Thousand-Year Reich, are still visible today. 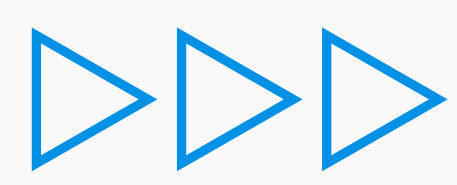
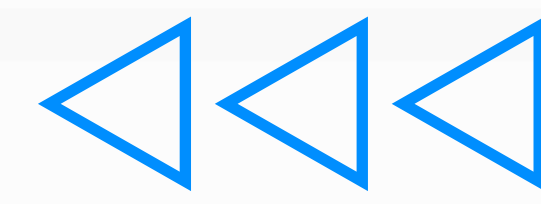

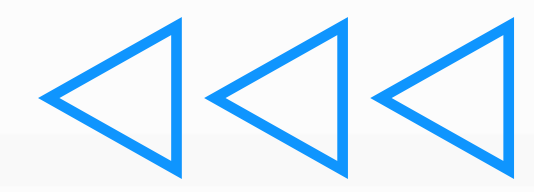

In-person or virtual presenters will have 13 minutes for paper presentation, and then 2 minutes for Q&A.

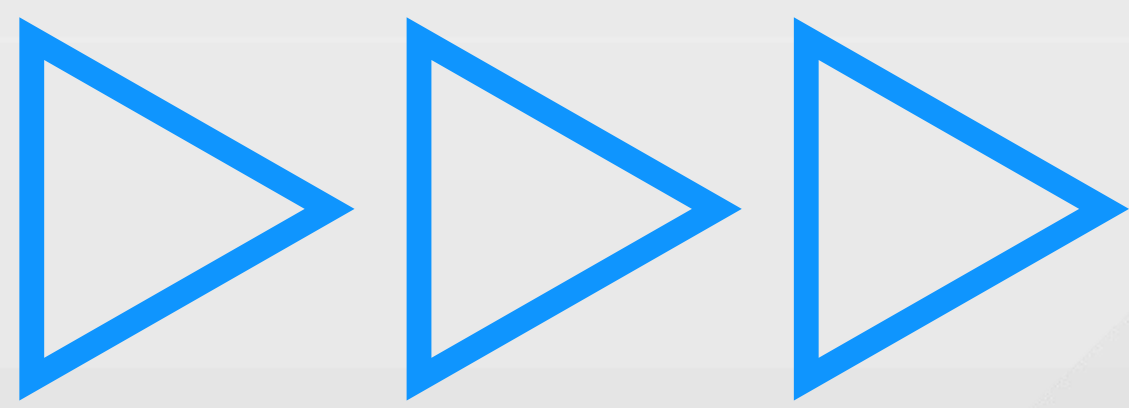
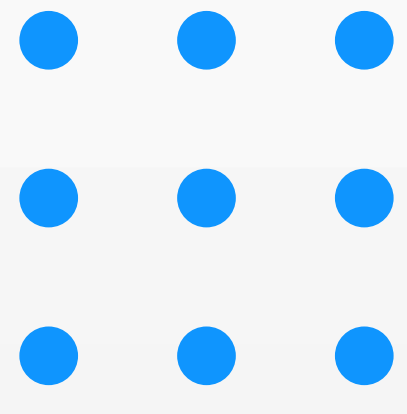
